This has created difficulties for them in accessing institutional healthcare services during times of illness and medical emergencies.

Foreign National PG students constitute an integral part of the academic and clinical workforce of AIIMS Bhopal and contribute meaningfully to patient care, departmental responsibilities, and institutional academic activities. **Extending EHS coverage to them under the student beneficiary category would ensure parity in healthcare access and support their overall well-being during the course of their residency training.**
